The Ministry of Commerce issues this Notification by exercising the power conferred under section 13 subsection (b) of the Export/Import Law.

**Wholesale/ Retail Business Registration of Export/Import Companies Trading  
Fertilizer, Seeds, Pesticide, Medical Equipment, Construction Material and  
Equipment, and Agricultural Machinery and Equipment**

1. The Ministry of Commerce, with the intention of ensuring wholesale and retail businesses in local owned by the foreign companies and the joint venture companies between foreigners and Myanmar citizens under the same registration system in line with the stipulation, issued the Notification No. 25/2018, Bulletin No. 2/2018 on the standard operating procedures for registration and Bulletin No. 3/2018 regarding 24 product categories on priority list.
2. Hence, foreign companies and joint venture companies between foreigners and Myanmar citizens that are importing fertilizer, seeds, pesticide, medical equipment, construction material and equipment and agricultural machinery and equipment by obtaining the certificate of exporter/importer registration under previous notifications 96/2015, 11/2016, 56/2016, 85/2016, 36/2017, 55/2017 and 63/2017 shall apply for wholesale/retail business registration in accordance with the provisions under Notification No. 25/2018 and Bulletin No. 2/2018 within 90 days from the date of issuance of this notification.
3. The aforementioned companies shall comply with the provisions under Notification No. 25/2018 and Bulletin 2/2018, and fulfill the requirements regarding the initial investment amount of the sale of goods and the floor area of the outlet within 5 years from the date of registration.
4. The companies that fail to comply with the provisions under this Notification shall be taken action under the existing laws and rules, and notifications, orders, directives and regulations issued by the Ministry of Commerce.
5. The notifications 96/2015, 11/2016, 56/2016, 85/2016, 36/2017, 55/2017 and 63/2017 are repealed by this Notification.
