**ASEAN Integration System of Preferences (AISP) အာဆီယံ ပေါင်းစည်းရေး ဆိုင်ရာ အထူးအခွင့်အရေးပေးသည့်စနစ်အရထိုင်းနိုင်ငံသို့တင်ပို့သောကုန်စည်များအပေါ်အကောက်ခွန် သက်သာကင်းလွတ်ခွင့်ပေးခြင်းကိစ္စ**

၁။ အာဆီယံအဖွဲ့ဝင်သစ်လေးနိုင်ငံဖြစ်သော ကမ္ဘောဒီးယား၊ လာအို၊ မြန်မာနှင့် ဗီယက်နမ်နိုင်ငံတို့၏ စီးပွားရေး တိုးတက်မှုကိုအထောက်အကူဖြစ်စေရန်အတွက်အာဆီယံပေါင်းစည်းရေးဆိုင်ရာ အထူးအခွင့်အရေးပေးသည့်စနစ် (ASEAN Integration System of Preferences - AISP) အစီအစဉ်ကို အကောင်အထည် ဖော်ဆောင်ရွက်လျက် ရှိပါသည်။

၂။ အဆိုပါအစီအစဉ်အရ မြန်မာနိုင်ငံမှ ထိုင်းနိုင်ငံသို့တင်ပို့မည့် ကုန်ပစ္စည်း (၆၈၂) မျိုးအပေါ် အကောက်ခွန် သက်သာကင်းလွတ်ခွင့် ပြုလာပါသည်။

၃။ ထိုင်း (AISP) အစီအစဉ်နှင့်အကျုံးဝင်စေရန် ထိုင်းနိုင်ငံသို့ တင်ပို့မည့်ကုန်ပစ္စည်းများသည် မြန်မာနိုင်ငံမှ ပြည်တွင်းထွက်ကုန်ပစ္စည်းများဖြစ်ရပါမည်။ ပြည်ပကုန်ကြမ်း ပါဝင်ထုတ်လုပ်သော ပစ္စည်းဖြစ်ပါက ပြည်တွင်းကုန်ကြမ်း ပစ္စည်း ပါဝင်ထုတ်လုပ်မှုတန်ဖိုး (၄၀ %) ထက်မနည်း ပါဝင်ရပါမည်။

၄။ ထိုင်း (AISP) အစီအစဉ်အတွက် ပင်ရင်းနိုင်ငံလက်မှတ်လျှောက်ထားရမည့်လုပ်ထုံးလုပ်နည်းသည် ကုန်သွယ်ရေး ညွှန်ကြားမှုဦးစီးဌာန၏ ၁၉၉၈ခုနှစ်၊ နိုဝင်ဘာလ (၂၄) ရက်နေ့စွဲပါ ထုတ်ကုန်သွင်းကုန်နှင့် ပတ်သက် သောသတင်းလွှာ (၁၆/၉၈) ဖြင့်ထုတ်ပြန်ထားသည့် Form - D လျှောက်ထားရာတွင် လိုက်နာ ဆောင်ရွက်ရမည့် လုပ်ထုံးလုပ်နည်း အတိုင်းဖြစ်ပါသည်။

၆။ ထိုင်းနိုင်ငံမှပေးအပ်သော AISP အစီအစဉ်ဖြင့်အကောက်ခွန်သက်သာကင်းလွတ်ခွင့်မှာ ၁-၁-၂၀၀၇ မှ ၃၁-၁၂-၂၀၁၀ နေ့အထိ (၄) နှစ်စာ အကျုံးဝင်မည်ဖြစ်ပါသည်။
